Acknowledgment, Release, and Waiver Form

In CONSIDERATION of allowing my minor child, ("the Participant"), to participate in the Miracle Junior Soccer Club's activities, the undersigned acknowledges, appreciates, and agrees that:

- 1. I am the parent/guardian of the above-named Participant having full legal responsibility for decisions regarding the above-named Participant;
- 2. I believe that my child is physically, emotionally, and mentally able to participate in the programs, activities, and events of the Miracle Junior
- 3. I hereby acknowledge that I am aware of the risks and hazards associated with or related to soccer. The risks and hazards include, but are not limited to injuries from:
 - Executing strenuous demanding physical techniques in soccer;
 - Dryland training including weights, running, and massage;
 - Grass, turf, and other surfaces including bacterial infections and rashes;
 - Falls to the ground due to uneven or irregular terrain or surfaces;
 - E. Collisions with walls and soccer equipment:
 - Failure to properly use any piece of equipment or from the mechanical failure of any piece of equipment; F.
 - Extreme weather conditions which may result in heatstroke, sunstroke, or hypothermia;
 - Contact, colliding, or being struck by other participants, spectators, equipment, or vehicles;
 - Vigorous physical exertion and strenuous cardiovascular workouts;
 - Exerting and stretching various muscle groups; and
 - Travel to and from competitive events and associated non-competitive events which are an integral part of the organization's activities.
- Furthermore, I am aware that my child may:
 - Sustain injuries in soccer that can be severe, cause spinal cord injuries, paralysis, and even be fatal;
 - Experience anxiety while challenging himself/herself during the activities, events, and programs;
 - Come into close contact with other participants, including the possibility of accidental and unexpected contact;
 - Risk of injury is reduced if he/she follows all rules established for participation; and
 - Risk of injury increases as he/she becomes fatigued.
- Therefore, I:
 - Assume all risks arising out of, associated with, or related to my child's participation; Α.
 - Am solely responsible for any injury, loss, or damage that my child might sustain while participating; and
 - Release the Miracle Junior Club and WeTogether & The Salvation Army Yorkwoods Community Church ("the Organization") from liability for any and all claims, demands, actions, and costs that might arise out of my child's participation, even though such risks, injuries, loss, damage, claims, demands, actions or costs may have been caused by the negligence of the Organization.

I UNDERSTAND AND AGREE, on behalf of myself, my heirs, assigns, personal representatives, and next of kin that my signing of this document constitutes:

- I am registering my child willingly and my child is participating voluntarily in these activities, events, and programs;
- I agree that there are risks in soccer as described above and my child will be exposed to these risks and hazards;
- I agree to accept all these risks and hazards and be responsible for any injury or other loss which my minor child might receive while participating in these events, activities, and programs. If however, I observe any unusual significant hazard during my presence or participation, I will remove my child/myself from participation and bring such to the attention of the nearest official immediately;
- If something happens to my child, I release the organizers of responsibility for any claims, demands, actions, and costs which might arise out of my child's participation. I understand "Organizers" to mean: the Miracle Junior Soccer Club. and their directors, officers, members, employees, volunteers, officials, participants, clubs, agents, sponsors, owners/operators of facilities, and representatives.
